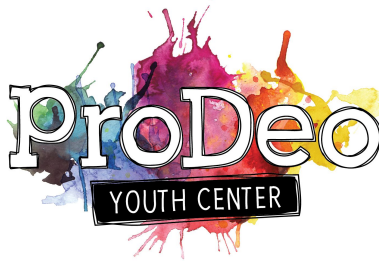

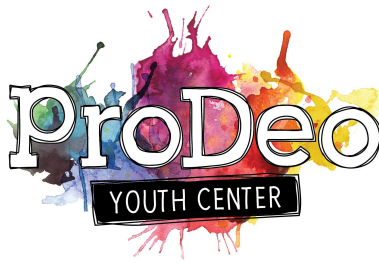

Code of Conduct:

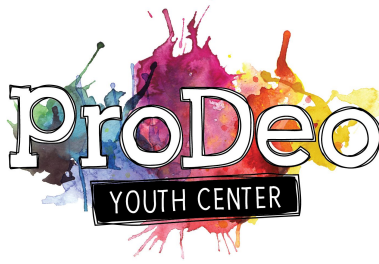
1. Be faithful to attend events you sign up for (please let us know 24 hours prior to an event if possible).
2. Remain in the immediate area of the event for the entirety of the event unless you have communicated with Pro Deo's staff and your parent(s), and have received permission to leave.
3. Interact and respect others (Students, yourself, staff, volunteers).
4. Be responsible for your actions and attitude by being open and teachable.
5. Go with the flow and honor Pro Deo and other's space and property.
6. This is an illegal substance, smoke-free, and weapon-free campus.
7. Encourage rather than put down others; use appropriate language.

If students are unable to adhere to the code of conduct or behave with disregard for others' safety, Pro Deo reserves the right to contact the student's parent(s)/guardian and/or the authorities.

Release Agreement:
